- electrification works goes to big companies on turnkey basis, which may purchases of At present there is 13.5% VAT on PSC Poles in Bihar whereas in neighboring States West Bengal & Jharkhand it is 5%. It would be important to mention that around 40 units manufacturing PSC/PCC Poles are functioning in Bihar but the contract for PSC/PCC poles. This may kindly be bear in mind that there is a liability of only 2% CST in case the goods are purchased from outside Bihar. In such circumstances, PSC Poles manufactured in Bihar becomes costly by 11.5% in comparison to the poles manufactured outside Bihar. This is badly hampering the prospects of PSC/PCC pole manufacturers. We, therefore, wish to request that VAT rate on PSC/PCC pole should be made 5%.
